## DIRECTOR, OPERATIONS REPORT

2022 WAS A YEAR OF RECOVERY IN SO MANY WAYS. WE STARTED THE YEAR WITH THE HOPE THAT WE WOULD BE RETURNING TO IN-PERSON CLASSES. OUR STUDENTS, THOUGH, HAD A COMPLETELY DIFFERENT IDEA ALTOGETHER. AT THE START OF THE YEAR, MOST STUDENTS WERE STILL NOT COMFORTABLE BEING IN A CLASSROOM SETtING, BUT OUR TEACHERS WERE VERY ANXIOUS TO GET BACK TO NORMAL DOING WHAT THEY LOVE IN THE BUILDING. IN THE WINTER, WE PILOTED THE BLENDED SYNCHRONOUS MODEL WITH ALL OTHER CLASSES REMAINING ONLINE. THIS WAS A SUCCESS AND TWO OTHER TEACHERS DECIDED TO JOIN THE WORLD OF BLENDED IN THE SPRING. IT WAS A blessing to be able to accommodate students' Choices and HELP WITH NAVIGATING THE FEAR OF GETTING BACK TO NORMALCY. WE DECIDED THAT ALL LOWER LEVELS OF STUDENTS (CLB 1 \& 2) WILL RETURN TO THE BUILDING AS WE QUICKLY LEARNED THAT IT WAS DIFFICULT TO learn english and Navigate technology at the same time. We KEPT THE HIGHER LEVELS IN THE BLENDED OPTION WITH OUR EVENING PROGRAM BEING TOTALLY ONLINE.

OUR LINC PROGRAM IN 2022 HAD A TOTAL OF 673 STUDENTS, WITH 264 STUDENTS BEING NEW TO OUR SCHOOL. WE HAD 113 STUDENTS MOVE UP levels within the school and 41 Of those Graduated out of AGAPE TO PURSUE HIGHER EDUCATION, CITIZENSHIP, OR EMPLOYMENT, STARTING THEIR JOURNEY OF BECOMING A TRUE CALGARIAN. WE STARTED TO SEE NEW ARRIVALS OF UKRAINIANS WITHIN OUR SCHOOL SYSTEM AND WE MAKE AVAILABLE AS MUCH AS POSSIBLE TO SUPPORT. IN OUR ESL PROGRAM, WE HAD A TOTAL OF 141 STUDENTS, WITH 75 BEING NEW STUDENTS. WE ARE VERY HUMBLED AT THE FAITHFULNESS OF GOD AS We Journey through the recovery of our province and city AFTER THE PANDEMIC.

## MIGRATING TO CANADA: A NEWCOMER'S PERSPECTIVE

It is with both mixed feelings and anticipation of a better life to receive the final documents to migrate to Canada. Leaving behind our support system of family, friends, our way of life, home, and the comfort of a government system that we have already become familiar with.

We arrive in Canada in the heart of winter without adequate clothing for the family, not knowing the language or having any friends in this strange country. It is difficult not to feel very confused as to where to begin and how to protect the children from hardship, a new school, and no friends.

We need to find shelter, meet with a government official to find out where to go from here, are in need of household items and clothing for the family with limited funds, look for work, learn the language, and a new school for the kids. The need is so large that our savings are being depleted quickly and with no way yet of replenishing what we have already spent. There is a feeling of overwhelming stress in making decisions that we have no way of knowing if they are right or wrong due to the language barrier.

Was it the right decision to move to Canada?

How do I provide for my family?

Will my kids be ok at school?
Is it safe for them on this bus that I do not know where they are going?

Where do I start?
My life begins with so much unknown, and the need to learn the English language fast to provide for our needs.

I take a test to determine what level my current English is, very nervous and uncertain.

On my first day of school, I meet my new teacher and classmates. I do not understand the teacher and in my head, I find I first translate to my language and then back to English. All around me, I hear this language; at the grocery store, at the doctor's office, and in school. However, I still struggle to understand.

As time goes on and we begin to become familiar with our new home, several semesters in my school allow me to finally be able to get around confidently and communicate on some level.

I am very grateful that I came to Canada, to a new way of life. I am moved by the support that a newcomer gets to fit into the community.

IMMIGRATION, REFUGEES AND CITIZENSHIP CANADA (IRCC) -immigration, réfugié et citoyenneté canada funds the LINC (LANGUAGE INSTRUCTION FOR NEWCOMERS TO CANADA) CLASSES.

2022 WAS THE YEAR OF RECOVERY AND THE HOPES OF RETURNING TO NORMAL LIFE FOR MANY, WHATEVER THAT MAY BE. AGAPE STUDENTS AND STAFF WERE NO EXCEPTION, WE EMBRACED THE FACT THAT WE CAN ONCE AGAIN BUILD COMMUNITY WITH OUR STUDENTS. IRCC HAS PARTNERED WITH US SINCE 1990 TO BRING THE LINC PROGRAM TO NEWCOMERS ARRIVING FROM ALL OVER THE WORLD WITH THE AMBITION OF LEARNING ENGLISH.

AGAPE PROVIDES PART-TIME CLASSES IN CLB 1-4 WITH OPTIONS OF MONDAY TO FRIDAY, MONDAY TO THURSDAY MORNINGS, MONDAY TO THURSDAY, TUESDAY, AND THURSDAY EVENINGS FOR A TOTAL OF 11 CLASSES. OUR LINC PROGRAM HAS THREE TERMS, FALL, WINTER, AND SPRING OFFERING STUDENTS THE OPTION OF ONLINE, BLENDED SYNCHRONOUS, OR IN-PERSON LEARNING. WE HAD 510 LINC STUDENTS ATTEND AGAPE UP 9\% OVER 2021, 327 OF THOSE WERE RETURNING STUDENTS, AND 183 WERE NEW TO THE PROGRAM. WE RECEIVE REFERRING CLIENTS FROM CLARC (CALGARY LANGUAGE ASSESSMENT AND REFERRAL CENTRE) TO US TO LEARN ENGLISH. ON AVERAGE OUR TERM COULD LAST ANYWHERE FROM 12 TO 15 WEEKS DEPENDING ON THE TIME OF YEAR. AN AVERAGE STUDENT COULD TAKE UP TO THREE TERMS TO MOVE A LEVEL IN THEIR READING, WRITING, LISTENING, AND SPEAKING BENCHMARKS. IMMIGRATION, REFUGEES AND CITIZENSHIP CANADA (IRCC) -IMMIGRATION, RÉFUGIÉ ET CITOYENNETÉ CANADA FUNDS THE LINC (LANGUAGE INSTRUCTION FOR NEWCOMERS TO CANADA) CLASSES.

IN FEBRUARY 2021, AGAPE WAS ONE OF FOUR SCHOOLS IN ALBERTA TO PILOT A PROVINCE-WIDE MODEL CLASS. DUE TO THE SUCCESS OF THIS MODEL AND THE GROWING WAITLIST WITH ARRIVALS TO ALBERTA, IRCC CONTINUED TO OFFER this CLASS throughout 2022 AND AGAPE REMAINS ONE OF SEVERAL SCHOOLS TO PROVIDE THIS OPTION. STUDENTS ARE FROM ACROSS THE PROVINCE, JASPER, LAKE LOUISE, HIGH LEVEL, HIGH RIVER, EDMONTON, AND CALGARY.

WE ARE SO VERY GRATEFUL TO IRCC THAT THEY CONTINUE TO INVEST IN AGAPE AND OUR STUDENTS BY PROVIDING THE NECESSARY FUNDING FOR NEWCOMERS TO LEARN ENGLISH. ALONG WITH THE INCREASE IN CLASS, THEY HAVE GIVEN US THREE ADDITIONAL SMARTBOARDS FOR THE CLASSROOMS WHICH BRINGS THE tOTAL TO 6 AND HAVE GIVEN US ADDITIONAL LAPTOPS TO HELP STUDENTS HAVE ACCESS TO EQUIPMENT.

# AGAPE LANGUAGE CENTRE SOCIETY NOTES TO FINANCIAL STATEMENTS YEAR ENDED DECEMBER 31, 2022 

## 1. PURPOSE OF THE ORGANIZATION

The Agape Language Centre Society is incorporated under the Societies Act of Alberta as a not-for-profit organization, and is a registered charity under the Income Tax Act. The Society is committed to an outreach ministry to new international neighbours. Our mission is to demonstrate God's unconditional love to our neighbours by meeting their need for English language and acculturation training through high quality interactive instruction in an accepting and affirming atmosphere.

## 2. SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared by management in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO) applied on a going concern basis.

## Use of Estimates

The preparation of financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, and disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amount of revenues and expenses during the reporting period. These estimates are reviewed periodically, and, as adjustments become necessary, they are reported in earnings in the period in which they became known.

Significant estimates in these financial statements include amortization of capital assets, deferred revenue and amortization of deferred contributions related to capital assets.

## Financial instruments

The Society's financial instruments consist of cash and cash equivalents, goods and services taxes receivable, and accounts payable and accrued liabilities. Unless otherwise indicated, it is management's opinion that the Society is not exposed to significant interest or credit risks arising from these financial instruments. The exchange values of these financial instruments approximate their carrying value, unless otherwise noted.

## Capital assets

Capital assets are recorded at cost. Assets with per unit cost of $\$ 300$ or less for general fund and assets with per unit cost of $\$ 1,000$ or less for LINC program are expensed in the year of acquisition. Amortization on capital assets is recorded on the following basis:

Computer equipment $30 \%, 55 \%$ and $100 \%$ declining balance
Office furniture and equipment $\quad 20 \%$ declining balance

In the year of acquisition, amortization is reduced by half.

## 2. SIGNIFICANT ACCOUNTING POLICIES (continued)

## Revenue recognition

Donations, fees and registrations for services related to courses and programs, and government funding are recognized as revenue when such courses and programs are delivered.

Designated contributions are recorded as deferred contributions until spent. Once spent, they are recorded to revenue on the same basis as the expenditure incurred.

## Contributed services

Volunteers assist the Society in carrying out certain activities. Because of the difficulty in determining their exchange amount and of the fact that such assistance is generally not otherwise purchased, contributed services are not recognized in the financial statements.

## 4. DEFERRED CONTRIBUTIONS RELATED TO CAPITAL ASSETS

Deferred contributions related to capital assets represent the value of capital assets acquired with funds provided by funders These deferred contributions are recognized as revenue at the same rate as the capital assets are amortized.

## 5. ECONOMIC DEPENDENCE

During the year, the Society received $\$ 412,939$ (2021 - $\$ 424,421$ ) Government of Canada grants, representing $84 \%$ (2021-86\%) of the Society's total revenue. As such, the Society's future economic viability is dependent on its continuance to receive such funding.

## 6. RELATED PARTY TRANSACTIONS

During the year, the Society made payments related to facility rental expenses, utilities expenses, photocopying fees, janitorial expenses, and Internet expenses totaling \$39,619 to Beddington Pentecostal Church. Beddington Pentecostal Church share a common Board of Directors with the Society. The Society also received donations of $\$ 23,000$ from Beddington Pentecostal Church. As at December 31, 2022, the Society has no outstanding amounts due to or receivable from Beddington Pentecostal Church. These transactions are measured at the exchange amount, which is the amount of consideration established and agreed to by the related parties.
